## 2018 Awards of Excellence Competition

### Call for Entries

The Florida Parking and Transportation Association is pleased to announce its 12<sup>th</sup> **Annual Awards of Excellence Competition**. The purpose of the competition is to recognize outstanding parking-related projects with the hopes of continuing to promote an appreciation of excellence in parking design, equipment, operation, and construction among the industry and the general public.

### Eligibility

Projects submitted must have been completed between **June 1, 2017 and August 31, 2018**. Only projects located in the State of Florida are eligible for the competition. You are invited to submit nominations in the following categories:

- I. Parking Structure – Design
- II. Parking Structure – Architecture
- III. Parking Structure – Renovation
- IV. Parking System – Innovation

### Awards Ceremony

During the annual ceremony, each finalist will be recognized. The Awards Committee will create a presentation based on project photographs submitted. Owners and parking related designers, vendors, suppliers, and contractors will be recognized during the project narrative.

### Form of Submission

Entries recommended for consideration should be submitted on the Awards Competition Prequalification Form (see below) with suitable photographs and descriptive data. Please note that photographs, details, or sketches demonstrating the unique use of parking innovations in design, operation, equipment, and construction will be taken into account by the judges. The submitted material must indicate the award category, as well as the outstanding features that merit judging.

**All submissions must be received no later than October 22, 2018.** Incomplete submissions will not be considered or returned.

### Judging

Members of the FPTA Awards Committee and FPTA Board Members will serve as judges for all categories. Projects will be judged based on outstanding conception, originality, aesthetics, and application in design, operation, management, and construction.

First round judging will take place in late fall 2018. Finalists may be notified with requests for additional material to be judged during the final round.

**Grand Prize Winners and Finalists** will be honored at the FPTA annual conference held December 4th at the Sawgrass Marriott Resort & Spa, Ponte Vedra Beach, FL. Awards of Excellence and Awards of Merit will be selected for each category.

5. Include letter from the owner in support of the submitted project, endorsing award recognition for the selected category.

Please see the Rules & Regulations for the specific criteria when completing a brief written description (no more than two pages double spaced) of the project citing the outstanding features that merit recognition. Additional information may be included such as: statistics such as height, square footage, structural system, and any unique use of parking equipment and/or operation. For the submission, please save this description as an MS Word file.
7. Please make sure all images are JPG files of high resolution. These images will be incorporated into the presentation for the awards program.
8. Please enclose an electronic copy of Awards Competition Prequalification Form (Items 1 through 5), written description (Item 6) and all images (Item 7).
9. Please submit one (1) complete electronic entry on CD or USB no later than **October 22, 2018**.
